### AIRPORT COURTESY VEHICLE AGREEMENT

Sequim Valley Airport, Inc a Washington Corporation, provides an Airport Courtesy Car for use by pilots from out of town. In exchange for use of this car, I agree to the following terms and conditions:

1. The undersigned, hereinafter referred to as "DRIVER", agrees to indemnify and hold harmless Sequim Valley Airport, Inc. , its elected official, directors, managers, officers, shareholders and agents, from and against any and all damages, loss, theft, or destruction of the Courtesy Vehicle (Vehicle) being provided to DRIVER by Sequim Valley Airport, Inc. and against all losses, liabilities, damages, injuries, claims, demands, proceedings, costs, and expenses of every kind and nature, including reasonable attorney's fees and disbursements arising out of and in connection with the DRIVER's use and operation of the Vehicle.
2. It is further agreed by the DRIVER that Sequim Valley Airport, Inc. shall not be responsible or accountable for any of the following:
  - a) property damage
  - b) personal injury(ies)
  - c) loss of business
3. The DRIVER is the only person authorized to drive the Vehicle and agrees to operate the Vehicle with reasonable care and diligence, and to follow all applicable laws of the State of Washington and Clallam County.
4. Driver also agrees to all requirements and restrictions detailed in the Airport Courtesy Vehicle Policy. A violation of any of the foregoing is a breach of this Agreement.
5. Every effort is made to keep the Vehicle maintained and in good operating condition; however, the Airport does not guarantee the condition of the Vehicle. The Airport has no obligation to provide an alternate vehicle or make alternate transportation available. 6. Use of the Vehicle without a properly executed Airport Courtesy Vehicle Use Agreement will constitute "unauthorized use of a motor vehicle" and could be prosecuted as such.
7. Driver must be at least 21 years old
